ADHD & Autism (ASD) Assessments

Right to Choose – Patient Guidance

To help patients access ADHD and Autism (ASD) assessments more efficiently, we ask that you follow the steps below **before requesting a referral**.

This process helps ensure referrals are appropriate, reduces delays, and directs patients to the correct provider first time.

Quick guide – 4 simple steps

1. **Complete an online screening questionnaire**
2. **Choose a Right to Choose provider**
3. **Check the provider's website for next steps**
4. **Book a GP appointment if required**

Step 1: Complete an online screening questionnaire

Before requesting a referral, please complete an **online screening tool** relevant to your concerns. These tools provide an **immediate outcome or score** indicating whether a full assessment may be beneficial.

Screening disclaimer (important)

These questionnaires **do not provide a diagnosis**.

A score suggesting ADHD or autistic traits indicates that **a formal clinical assessment may be appropriate** but does not confirm a diagnosis.

Step 2: Choose a Right to Choose provider

If your screening results suggest you may benefit from further assessment:

- Review the **Right to Choose ADHD/ASD provider list**
- Select your **preferred provider**

Right to Choose Provider List

(Link to your ICB or practice-hosted list)

Please note:

- Providers must hold an NHS contract
 - Providers set their own acceptance criteria
 - Waiting times vary significantly
-

Step 3: Check the provider's website for next steps

Each provider has different referral processes. Please review their website carefully to confirm:

- Whether they accept **Right to Choose referrals**
- Whether **self-referral** is available, or
- Whether you need to **book an appointment with a GP**

Some providers require:

- Specific referral forms
 - Screening results
 - Additional questionnaires

Step 4: Arrange next steps

Depending on the provider's process:

- Complete the provider's **self-referral**, or
- Book an appointment with a GP to discuss:
 - Your symptoms
 - Screening results
 - Your chosen provider

Your GP will confirm whether the referral is **clinically appropriate** and submit it if indicated.

If you're unsure

If you are unsure:

- Which screening tool to complete
- Which provider to choose
- Whether you need a GP appointment

Important information about treatment & shared care

- Some providers may recommend medication following diagnosis
 - **Shared Care Agreements are not automatic**
 - Any request for shared care will be reviewed in line with local prescribing policies and clinical judgement

While Right to Choose can reduce waiting times for some patients:

- Demand remains high nationally
- Assessment timelines vary between providers
- Follow-up support depends on the chosen provider

We appreciate that waiting can be frustrating and aim to support patients as best we can.
